# ANNUAL CONGREGATIONAL MEETING February 8, 2015

The congregation of the First Presbyterian Church of Ada, Oklahoma, met for its Annual Congregational Meeting immediately following the church service on February 8, 2015.

Bob Rogers, from the Indian Nations Presbytery Committee on Ministries, served as Moderator of the meeting. He declared a quorum of the congregation present and opened with prayer.

Moderator Rogers called attention to the following:

Moderator Rogers reviewed all reports and gave opportunity for congregation members to ask any questions.

#### **CALLED CONGREGATIONAL MEETING**

March 8, 2015

The congregation of the First Presbyterian Church of Ada, Oklahoma, met for a called congregational meeting immediately following worship service on March 8, 2015. The purpose of the meeting was for presentation from the Pastor Nominating Committee (PNC) of a candidate, Rev. Scott White, for nomination to the congregation.

Bob Rogers, our liaison from the Indian Nations Presbytery Committee on Ministries, served as Moderator of the meeting, declared a quorum of the congregation present, and opened with prayer.

Moderator Rogers first explained to the congregation his role as moderator and the order of business to be presented.

Next, Moderator Rogers asked members of the PNC to come forward. The PNC was made up of the following:

Regina Robertson explained the extensive process used by PNC to arrive at the nomination of Rev. Scott White. The PNC has held 38 meetings since June along with numerous e-mails. Each meeting opened with Bible study and closed in prayer. Regina thanked the congregation for praying for PNC during this time. PNC reviewed "wish list" of attributes and qualities the congregation desired in a pastor. Mission Information forms (MIFs) were filled out using information provided by the congregation and posted for individuals to reply if they were interested in looking at us. PNC reviewed over 34 candidates matching criteria with what our congregation needed and wanted. They held initial telephone interviews with individuals who met criteria, listened to sermons, and held second interviews over Skype. Throughout this process they felt one candidate stood out above the others and invited Rev. Scott White to come to Oklahoma. On February 13-15 Rev. White and his wife, Miriam, visited Ada. During that time he also met with Presbytery Commission on Ministry and preached at a neutral site. With a unanimous vote of the PNC and with the blessing of the COM, Regina presented Rev. White for nomination to our congregation.

JoAnn Carpenter introduced Rev. Scott White, his wife, Miriam, and their three children, Elliott, Teresa, and Anthony. Rev. White and Miriam have been married for 22 years and presently reside in Michigan. In addition to his interests for family and the ministry, he also is involved in yoga, horseback riding, home improvement, and sports.

Moderator Rogers asked if the congregation had any questions for the PNC. There being no questions, Moderator Rogers asked the White family to come to the platform. Our church had

listed Bob Rogers as a reference for us, and Rev. White called him. With Rev. White's permission, Moderator Rogers gave a small portion of his interview with Rev. White. One of Rev. White's questions was "What does the congregation in Ada want from me as a minister?" Moderator Rogers told him we were a caring, mission-oriented congregation who needed some guidance. Rev. White replied, "They need somebody to love them." By the burst of applause, the congregation whole-heartedly agreed with that statement. Rev. White said he has felt very very loved through all contact with PNC and congregation.

Moderator Rogers asked if the congregation had any questions for Rev. White. Adam Hampton asked, "What do you and your family need or expect from us to help you not only in your assimilation into the community but as a church and pastor relationship?"

Rev. White replied, "We have shared information about who we are and our journey as a family. You have shown us around Ada and made introductions. That has been so helpful, and I ask for more of the same to be in contact with us and connect us to things we are hoping for here in Oklahoma. In terms of integration into the congregation, I would be asking for numerous meetings. I would be asking for numerous meetings, even Saturday morning meetings, with the staff and session in order to integrate me in and talk about leadership and congregational development. This will help orient me, tell me your views about the model that's been at work here, and have some opportunities to offer some suggestions."

There being no further questions from the congregation, Moderator Rogers asked Rev. White and his family to step into the parlor.

Matt Sweatt and Brooke Holman presented the financial package that has been offered to Scott which he has agreed to.

Moving expenses of \$7,500.00 will be provided by the church. Another item is a three month sabbatical which was every seven years at Rev. White's other church. He would like to carry over his accrued five years which would make his next sabbatical in 2017. PNC felt 2017 would be too soon so they negotiated to carry over three accrued years making the next sabbatical in 2019 and occurring every seven years afterward. This is also known as a clergy renewal period and is a typical item in terms of call. Rev. White advised he uses this time for reading, prayer, and visits to other congregations. It is an educational time for the pastor. Standard terms of call also include 30 vacation days including four worship Sundays and 14 calendar days which includes two Sundays for continuing education. Effective start date is July 13, 2015 to allow children to finish school year and move to Ada. Betty Brown thanked PNC for the time and effort they have given, and congregation gave an enthusiastic round of applause.

Moderator Rogers made sure there were no more questions and that everyone understood the terms of call and outlined the rules of the vote. Ballots were passed out by members of PNC and only members of First Presbyterian Church of Ada could vote. Ballots were collected and PNC members overseen by Nancy Thompson and Elmer Brown, PNC members at large, left the sanctuary to count the votes.

While the votes were being counted, Moderator Rogers gave some of his experience over the last several months during our search for a pastor. Before the PNC was formed, the process began with one of the best mission studies he has seen since he's been on the COM committee. He asked members of that committee to stand and be recognized. Jill Acree, Nancy Thompson, Amy Elliott, and Will Rauch were present. Bill Brooks was a member of that committee but has since married and moved out of town.

The next step was a session meeting held for the purpose of listing sixteen characteristics the session thought should be covered by the members of the PNC. Session members matched names to the 16 characteristics and developed a list of nine PNC members. Moderator Rogers asked session members who had been present at that meeting to stand and be recognized.

Moderator Rogers talked about what a pleasure it had been to work with PNC. They had been well-organized, willing to take on tasks, and worked well together.

Members of PNC and Nancy Thompson returned with the results of the balloting: It was UNANIMOUS to accept the nomination of Rev. White by the PNC.

The congregation will now be tasked to do several things. The first is to determine who will sign the Terms of Call before it is forwarded to the Presbytery. The congregation can choose anyone, but historically all members of the PNC sign the document.

Motion was made, seconded, and carried to approve all members of the PNC to sign the Terms of Call for Rev. Scott White to be forwarded to the Presbytery.

Next, after Rev. White arrives in July, he will need to be presented to Indian Nations Presbytery at the first available meeting which will be held in Ardmore in October.

Motion was made, seconded, and approved to nominate Kay Shaw, Primary Commissioner, and Teresa Mayhue, Alternate Commissioner, to present Rev. White to the Presbytery at its meeting in Ardmore in October. It is recommended that as many members of the PNC that will be able to attend the meeting do so as a show of support for Rev. White.

Rev. White and his family were brought back into the sanctuary to a long and loud round of applause, and Moderator Rogers advised the vote had been unanimous.

One last item of business was to dismiss the PNC. Moderator Rogers acknowledged the amount of work put in by PNC members has been astounding and the results speak for themselves.

Motion was made, seconded, and approved to dismiss the PNC with gratitude.

Motion was made, seconded, and approved for session to approve minutes of this meeting at the next session meeting.

Motion was made and seconded to adjourn the meeting. Moderator Rogers adjourned with prayer.

The congregation of the First Presbyterian Church of Ada, Oklahoma, met immediately following the worship service on October 11, 2015 in the church sanctuary, as previously communicated to the congregation.

Moderator Scott White called the meeting to order and offered prayer.

Scott apprised the congregation that the meeting had been called by the Session on September 27<sup>th</sup> with the one item of business being the election of a Nominating Committee to serve the congregation in the year ahead or until the next Nominating Committee is formed.

Scott declared a quorum to be present.

#### Christian Education Financial Procedures

#### Mission and Evangelism Annual Report 2015

2015 was a good year for the Mission and Evangelism Committee.

- We began a discussion concerning the best use of our budget. - The Alternative Christmas market was another huge success. In addition to having a great time, we were able to raise \$6752 for causes around the world. Big thanks to Brooke Holman and the many other men and women who contributed to the resounding success of this event.
- Following the Alternative Christmas Market, we continued our annual tradition of handing out cookies and hot chocolate and cookies at the Ada Parade of Lights which not only served the community and allowed us to meet hundreds of people, but also gave us an opportunity to invite people to the live nativity. This event was a huge success and fun was had by all. Many thanks to all of the wonderful volunteers who made this a success.
- Our final event of 2015 was the live nativity which was a resounding success. Estimates differ but range between 150-200 cars that came through our church campus to hear and see the story of the birth of Jesus. Snacks and drinks were handed out by volunteers and many people got out of their cars to visit and to linger on the sidewalk in front of the nativity for a while.
- In the spirit of Christmas, we felt the call to give congregation members the option of donating money to support an organization dedicated to the relief of the citizens of Syria who were most directly impacted by the political unrest in the country. On Christmas Eve we were able to raise \$1135 to send to "Syria Relief" which works inside Syria to bring food, water, shelter, and medical attention to the civilians who most desperately need it.
- We are excited about 2016! We are working on some new volunteer opportunities and "mission trips" for the congregation, and are continually trying to sense where the Spirit is leading us next. Thanks to all!

#### Stewardship Report

The purpose of the Stewardship Committee is to:

#### **Property Report**

- Normal maintenance of the building and grounds occurred.
- Numerous repairs to the HVAC units were required, including the replacement of the outside A/C unit for the WFC Foyer and Sunday school rooms.
- All thermostats located on the campus, excluding the two located on the south end of the WFC, were replaced with OG&E's 'Smart Hours' thermostats.

The committee thanks all church members and volunteers that assisted with the care of the church and its grounds throughout the year, either during a scheduled work day event, or as a donation of their own time.

### First Presbyterian Church Foundation of Ada, Oklahoma

Foundation Trustees: Doug Haney, Charlie Mayhue, Jack Lambert

On April 25, 1999 the church congregation of the First Presbyterian Church of Ada adopted and approved the By-laws of a new corporation incorporated on March 29, 1999. The corporation is known as the First Presbyterian Church Foundation of Ada, Oklahoma. The Foundation is a separate entity from the church formed to receive and administer assets to provide for the future capital improvements of the church, help make possible the long term expansion of church facilities and major maintenance and renovation of these properties, to give the current church members the ability and freedom to focus their efforts on the current program ministries and current mission involvement of the church and for special projects which are in addition to and beyond the scope of the operating budget. The membership of the Foundation is comprised of the members of the First Presbyterian Church of Ada. The current bylaws of the Foundation state one-fifth of the annual income from the assets can be used to finance special projects as designated by the session, one-fifth of the annual income is to be used for on-going capital improvements and three-fifths of the annual income is to be added to the corpus of the Foundation's assets.

The beginning asset balance on January 1, 2015 was \$191,487.35. At year end the total assets were \$194,513.04 incurring a net increase of \$3,025.69 in assets. The net income for 2015 was \$3,025.69. A distribution will be made in 2016 for the 2014 year in the amount of \$2,581.24 and for the 2015 year in the amount of \$1,210.36 to the First Presbyterian Church as dictated by the bylaws of the Foundation. Proceeds from distributions are always held until the Session designates how they will be spent in the area of special projects and on-going capital improvements.

The Foundation assets are managed by a three member board, one elected by the Membership of the Foundation, one appointed by the Stewardship committee and one appointed by the Session. At December 31, 2015 the board members included President Charles D. Mayhue; appointed by Session; term expired 2015, Vice-President Doug Haney; appointed by Stewardship Committee; term expires 2016 and Secretary/Treasurer Jack Lambert; elected by church membership; term expires 2017.

The Foundation is the beginning of a vision by many First Presbyterian Church of Ada members and will benefit many generations of First Ada Presbyterian causes. The Foundation is a great vehicle for charitable contributions given to the church for purposes beyond the current budget needs.

#### Presbyterian Women 2015 Report

Presbyterian Women (PW) serves the local church and contributes to the mission of Indian Nations PW, Synod of the Sun PW, and PCUSA PW. All the women who belong to this congregation are members of Presbyterian Women.

Our local PW continues to sponsor a 9-month bible study, September-May. There are two classes, one on the second Sunday of the month at 6 PM, the other on the second Tuesday at noon. We are blessed to have Jill Acree, a graduate of Austin Seminary, leading the study. Participants enjoy the fellowship and share their insights. All are welcome, male and female.

PW celebrated the Alternative Christmas Market by buying a well to help bring potable water to a village in Africa. We also extended our church's outreach to the Matthew 25 mission with a contribution for the Christmas food distribution.

A special privilege in 2015 was the opportunity to assist three women--Emily Clifton, Jill Acree, and JoAnn Carpenter--to attend the triennial Churchwide Gathering June 18-21 in Minneapolis. Other contributions by PW last year include the purchase of seven folding tables for use in the WFC and a large Christmas tree suitable for the big open center space in the WFC.

Annual "garage sales" provide most of the funding for the local PW. Moderator Greta Thompson, with help from many others in the congregation, continues to oversee these sales.

#### **Pastor Report 2015**

Thank you for calling me to serve here, and for your warm and gracious welcome of me and my family! I will provide retrospective reporting on the start of my ministry here, and some prospective remarks about my hopes for our near future together, and what I see in it.

I and my family were welcomed. The staff welcomed and oriented me. The session and I met for three Saturday morning mini-retreats, as well as for five stated meetings. In the mini-retreats we synced up on the biblical vision of the church, Reformed theology and governance, and the duties of the session and its moderator to manage and advance the mission and ministry of the church. In my short time here I have seen the session planning and coordinating the witness of the church, and doing so smartly, efficiently and well.

Elders also made time to confer with me to orient me to their ministries and to apprise me of our growing edges and to give me good ideas on how to be of support.

Congregationally we began praying together, celebrating the sacraments together, worshipping together, studying together, fellowshipping together, reaching out together, and visiting each other. Thank you for stopping in to the office. I have also very much enjoyed visiting you in your homes and places of work. In my first 6 months I could only visit a portion of the congregation and I will push ahead in 2016.

Thank you so very kindly for your support of the installation service and for the generous reception following.

I provided a start-up plan to the session as we began, and tracked against this plan in my first four months. The basic idea is I am to listen, learn, integrate into the life of the congregation (and community and presbytery), get going and begin leading—following our Servant Lord.

I began learning FPC's ministries and the work of the congregational groups, and began providing support. A high priority for me in 2016 is to support the Mission and Evangelism and Stewardship ministries. In staff meetings we coordinated our responsibilities as staff and began cohering as a team.

I enjoyed being at Wednesday Night Live and offering mini-messages there, ran some new member orientations, which were a joy, and elder orientation for the class of 2018, which also was a joy. We studied together at the Consolidated Adult Study (Sunday mornings in Advent) and gave particular focus to the Lord's Supper in midweek service Wednesday evenings in Advent.

The Ada Ministerial Fellowship warmly welcomed me, and a number of area pastors graciously wanted to meet personally. I am serving on the advisory board and resources committee of the new homeless shelter Mama T's Bread and Blessings. I am moderator of the Indian Nations Presbytery Youth Ministry committee, and member of the INP Congregational Ministries committee.

The startup plan is essentially complete.

What does a pastor/head of staff/moderator of session/moderator of congregation do? In a nutshell, provide a diverse and balanced ministry of preaching, teaching, pastoral care and

organizational leadership. Pastor prays for the people, meets them where they are, and asks how to be of service.

What I see in the congregation is you are the body of Christ. You are God's people with faith and spirit alive in you. I arrived in July in the week of youth mission in the community—it was impressive to see that, and count on me to encourage the church to send groups in outward mission in the future, and hopefully to be part of them. We have shared the good news together on Main Street (Parade of Lights), on the church grounds (Live Nativity), and at area nursing homes (Christmas caroling). I saw you at work at Abba's Tables and Compassion Outreach and in our sanctuary and in our church school classrooms and in uncountable ways.

What I see in our near future is a strengthening of our core ministries and congregational infrastructure. Our core ministries of course are the worship, the study, the outreach, and the inreach. Our congregational infrastructure is property, finances, and personnel. My attention is locked on all these areas.

Let me write in particular in this report about our property infrastructure. We are blessed with a wondrously good campus; there is no doubt about that. And the sanctuary is our best room, which is also a blessing. However there are some real questions as to how well some of our spaces are configured for the congregational ministry and mission as they currently exist, or are expected to exist in the near future. Also, it seems a portion of the campus has lost some of its attractiveness—in comparison to when it was first crafted and appointed. The Stewardship committee and whole session are currently reviewing a list of prospective improvements to the campus. Each will be carefully assessed in terms of what (and how much) is faithful for us to do. You will hear more about this in the months ahead. In the meantime I ask you to do some thinking about the campus high and low and all around.

What I hope for in our near future is an easy thing for me to hope for. Namely, that you will continue to follow the Lord Jesus Christ, enjoying the companionship and ministry of the Holy Spirit, to the praise and glory of God our Father. Life is short, and we're disciples. We're meant to give total commitment to the Lordship of Jesus Christ in the whole of our lives, all the time. What I hope is you will allow me to shepherd (pastor means shepherd) and encourage you in what that commitment to the Lordship of Jesus Christ means and looks like...while we also remember God's great grace.

The rich tradition provides us with a long list of what this commitment means and looks like. From that let me lift up a few key encouragements for 2016:

Hire on to one or more of the congregational ministries. The team that manages and advances congregational ministry is called a committee. Everyone should serve in and through at least one of these. You'll be blessed, as well as be a blessing. Oh, you will find Jesus as a church school teacher. Oh, you will find Jesus as an organizer of a mission trip. Oh, you will find (and speak to) Jesus while you are washing the congregational dishes or installing new ceiling panels. I one hundred percent guarantee this. Check the back of the Sunday morning bulletin and make the call to one or more elder-leaders and say, "I want to find Jesus through the work of the committee!"

Serve God and neighbor with energy, imagination, intelligence and love.

Go to Wednesday Night Live, which also means the adult study, and—if it's your calling—choir.

Rest as part of your devotion to God, as well as labor. In this world when you say no to work work, church work, community work, or mowing the lawn during your Sabbath day you are witnessing bright and strong.
